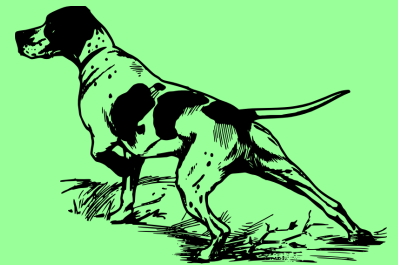

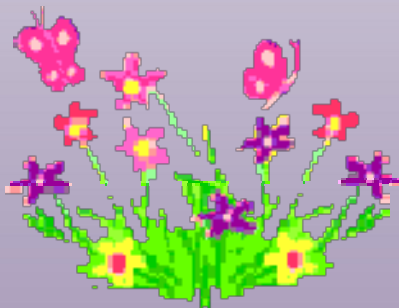

WANTED!

WSOTC NEEDS NEW DELEGATE

For health reasons, WSOTC's AKC Delegate, Jim Smith, will not be able to continue in his role, so our Club must select a new Delegate. This is kind of a big deal. Out of over 5,000 affiliated (show/trial giving) clubs in AKC, only about 600 are "member clubs" entitled to a Delegate. WSOTC is one of them. Not many of those are obedience clubs, so we are fairly privileged in having a Delegate. The role of a Delegate is basically two-fold. One is to attend the four per year meetings, to represent WSOTC and to vote on the various issues that come up. Generally, 3 of those are in the New York/New Jersey area and one is in Orlando, Florida. The other side is to represent AKC to our Club and to be a conduit of information from AKC to inform our Club as to what is going on.

The latter, may in fact be the more important of the two, as most important matters of AKC, including approving new obedience regulation, fall to the AKC Board of Directors. Critically, the Delegates do vote on the members of the Board of Directors, which just occurred at the March Delegates meeting. This can set the tone of what sort of direction AKC will take. In addition, the Delegates do make recommendation to the Board for decisions.

It is a bit of a long process to seat a Delegate, but here is how I understand it. Once the Club selects a Delegate (must be voted by the membership) both that person and the Club, fill out an application, send to AKC. Then it must be published twice in the AKC Gazette (after which presumably, people can object to that person). Then it is put on the agenda of the next AKC Board of Directors meeting for their approval. With this schedule, if we get the process started by selecting someone at the March 31 meeting, it would likely be the September Delegates meeting before we could have someone on Board.

Jim Smith did not have any recommendations for a replacement, but I talked with Betty Winters, who is a long time Delegate for the Olympic Kennel Club. She knew of someone who might be available. His name is Jack Cadalso, and he was at the Delegates meeting with Betty, just held March 13. Betty talked with him, and he is interested in being our Delegate. He is currently a Delegate for the Troy Kennel Club, but will be leaving that position and able to take on the one for WSOTC. Delegates can serve as Delegate to only one Club. Jack is an agility judge and has judged in this area several times, including for my Golden Club, very popular and well liked. He currently serves on the Companion Events Committee (with Betty), and was, I believe, recently selected as Secretary of that committee.

Jack is retired. He has homes in Albany New York and in Wilton Manors, Florida, though will likely be spending more time in Florida. There are of course costs involved in traveling to the meetings, as well as hotel and other expenses. Apparently, a common practice for member clubs is to pay Delegates per meeting, with \$200-\$250 being a common fee. Some Clubs may pay the entire amount of expenses, others pay little to none, it is just something that has to be worked out between the Club and the Delegate. The WSOTC Board would make the deter-

mination of what we can offer. The other financial consideration is that Delegates who are judges are not allowed to accept a judging fee, only their expenses. Jack has already agreed to this and despite a judging assignment of about 18 weekend a year, he enjoys being a Delegate enough that he accepts that restriction. Jack has agreed to accept what WSOTC offers. Although WSOTC did offer expenses to Jim, as far as I know, did not submit any invoices. I cannot say for certain how many he actually attended. AKC requests that the Delegate make a five-year commitment to being the Delegate, an advantage for both AKC and the Club. Jack has agreed to do this.

In the past, WSOTC has had members who have been Delegates and paid part of their expenses. It is certainly an advantage to have a member Delegate, though for us on the West Coast, the expenses can be greater for the club and more of a commitment for the Delegate due to the extra travel time. So, if there is a possibility that a member of our Club would like to do this, we would love to know this. If you would like to do so, you should indicate your interest as soon as possible to Terrie Sato, so that we can get started with the process, hopefully at the March 31 meeting. Be sure to note our 2018 prices (our first price increase in 10 years!), and the Auburn location for this TMT/RAR.

DONIDA FARM LOCATION: This TMT & RAR will be held at Donida Farms, 16600 SE 376th, Auburn, WA 98092. You will receive detailed driving and parking directions in the confirming email, along with instructions for crating, pottyng dogs, etc. Donida Farms offers a wonderful, packed dirt, fully enclosed 70' x 150' riding arena for our use.

FLOORING: This is a packed dirt floor, so bring a tarp to put under your crate.

RING SIZES: We will have three rings side-by-side with room for crating on the dirt or adjoining concrete.

CRATING: This is a packed dirt floor, so bring a tarp to put under your crate. Or you may choose to crate out of your vehicle. There are no loaner crates at this venue.

POTTY AREAS & PARKING INFO: All parking and dog potty areas will be clearly identified. Dogs are not allowed in areas where horses are boarded, training or working. Be sure to CLEAN UP.

MAIL PRE-REGISTRATION: So that we have time to do all the scheduling, mailed pre-registrations must be RECEIVED in our office by the pre-registration deadline noted on the first page.

IN-PERSON PRE-REGISTRATION: If you are in classes or it's convenient to drop the form off at our office, you may also register that way. We have a mail slot in our front door.

RALLY RINGS (10 am to Noon): \$12 for 6 minutes. Limited to 20 runs. Courses will be set up starting with Masters, then Exc/Adv then Interm/Nov. Walk-through times will be provided when we send out the run order and schedule.

OBEDIENCE RINGS (10am to 2pm): \$15.00 for 12 minutes. AKC & CKC & UKC – Beginner Novice, Pre-Novice, Novice, Graduate Novice, Pre-Open, Open, Graduate Open, Pre-Utility, Utility and Versatility are available. Group exercises for Sit Stays and Down Stays will be held every 60 minutes. Rent A Ring handlers may also participate in stays.

RENT A RING (10 am to 2 pm): \$25 for 20 minutes. Jumps & cones for posts are provided, but no judge or stewards are provided. Rent A Ring sessions are for folks who want to "do their own thing" – either alone or with a maximum of one other handler sharing the ring time.

AGGRESSIVE DOGS: No people-aggressive or dog-aggressive dogs are permitted at this event.

REGISTER EARLY: Our events typically fill up weeks in advance!
