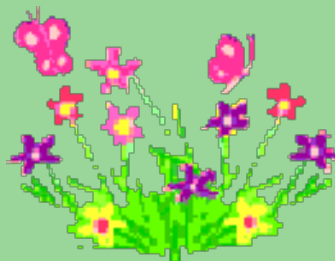

**Do you know how many stewards it takes to run an Obedience and Rally ring smoothly?**

**On average, an Obedience ring needs 3 stewards for each ring, for there to be enough to cover each role and to allow for the ring to keep moving throughout the day.**

**For Rally, 5 stewards is best, but 4 is really the minimum needed.**

**That means for our shows, we need between 6 and 9 stewards for Saturday and Sunday. For Monday, between 8 and 10 stewards.**

**Thank you to those who have already volunteered to steward for the Fall Obedience and Rally trials. We are still in need of several stewards. Rally is needing quite a bit more and Saturday is also in greater need. We could use a couple more for Sunday. You can show and steward. If you are only available for part of the day, that is fine, as we do have some stewards needing relief when they show. For the last several years our contract with them has included many of the tasks previously carried out by the chair, something which makes taking on the agility chair a much more doable job.

We had efficient course builders, a great ring crew, and great exhibitors, good sports one and all who cheered on their fellow exhibitors. An added and popular attraction was the availability of CGC and Trick Dog titles due to the efforts of Evaluator Paula Ratoza (also an agility judge, and who exhibited at our trials). Extra fun and titles for many who tried something new, and some income to support the trials. Thanks also to Argus Ranch who supplied the facility and other support for us. The future of Argus as a center for agility and other dog sports remains unknown as it is currently on the market. We are watching that closely.

**FLOORING:** We hope you enjoy our Everlast flooring as much as we do. Please help us keep our floor clean and beautiful by NOT bringing soft drinks, coffee drinks, etc., onto the floor. Please keep beverages on the tile flooring.

**RING SIZES:** Two full-size Utility rings (40 x 50) will be set up in our large training area (Rings 1A & 1B), which has plenty of room around the rings for warm-up. **OBEDIENCE RINGS (9 am to 4 pm): \$15 for 10 minutes.** AKC & CKC & UKC – Beginner Novice, Pre-Novice, Novice, Graduate Novice, Pre-Open, Open, Graduate Open, Pre-Utility and Utility are available. Group exercises for Sit Stays and Down Stays will be held every 60 minutes. Rent A Ring handlers may also participate in stays.

**RENT A RING (9 am to 4 pm): \$25 for 20 minutes.** Jumps & cones for posts are provided, but no judge or stewards are provided. Rent A Ring sessions are for folks who want to "do their own thing" – either alone or with a maximum of one other handler sharing the ring time.

**AGGRESSIVE DOGS:** No people-aggressive or dog-aggressive dogs are permitted at this event.

**REGISTER EARLY:** Our events typically fill up weeks in advance!

- **ATTITUDE IS EVERYTHING!** The most important thing to me is building the “right” training relationship by building the the dog’s “want to” attitude BEFORE adding the “have to”. It is also important to me to keep the dog’s positive attitude throughout their long show career by keeping training sessions fun.
- **ERROR-FREE TRAINING:** I create the finished dog by building on success, not failure, and the effective use of positive proofing to build confidence and consistency.
- **REWARD-BASED TRAINING:** I have control of the rewards and use them correctly to train, motivate to get the most out of my dog.
- **FOCUS ON FUNDAMENTALS:** I continue to focus on the foundational skills throughout the dog’s show career.

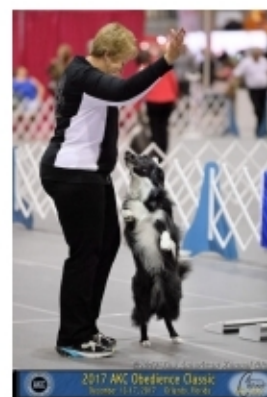

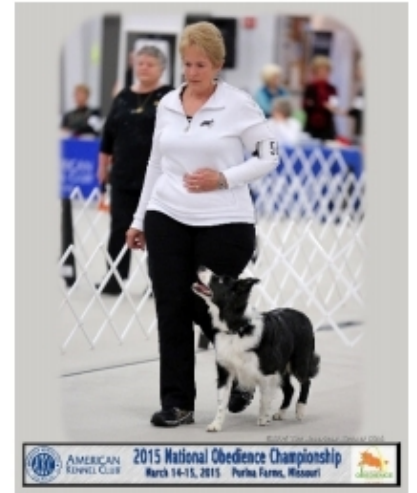
