

### Connie Cleveland-Nolan Seminar

Connie Cleveland-Nolan presented her problem solving seminar on Sept. 15 and 16 to a very attentive group of dog trainers. Though Connie's seminars are billed as problem solving, they are so much more. Connie offers dog trainers some very basic principles to stick with while training. Her message is that principles don't change, techniques do. Goals do not change, the method to reach that goal might.

Connie has become a great advocate of the Conditioned Reinforcer (CR). As she explained, the CR not only points your finger at exactly what you as a trainer like about a behavior, it builds a dopamine release that leads to anticipation of the behavior becoming rewarding. In fact, the words, 'mark it and pay it' could have been the buzz phrase of the seminar.

Connie treated all twenty participating dog handler teams as individuals, devoting total attention to the team on the floor. Many times she pointed out that our dogs knew more than we thought. As a believer that dogs learn by showing, she did not hesitate to point out the correct path, even to the point of picking up a Newfoundland and placing it over the broad jump! And yes, the dog took the jump on the very next try.

To explain the dog/handler relationship, Connie used examples participants could relate to. For example, she pointed out that as we prepare for competition, we are a coach. Her comment, 'you are the coach, not the cheerleader' and that we need to ask our dogs for 100% effort as we go into the ring, offered a unique perspective to prepping for an obedience trial.

As an engineer by education, Connie has the ability to diagram the necessary steps to achieve a goal. She offers logical training steps. An example is teaching directed jumping before teaching the retrieve over the high jump. This allows the dog to have an understanding of returning over a jump as well as gives the trainer a tool, arm out showing the way, to deal with dogs that want to come around the jump.

Connie also explained her method of making time to train. She suggested looking at the weekly or bi- weekly calendar and crossing out days you won't be able to train. This way you will be able to see the days and times available and fill in the blanks accordingly. If you have 15 minutes to train, plan to train the exercises you need the most. Make a list of the exercises you need to teach or train and prioritize. The priority changes with time as the dog improves.

Every participant and observer reacted with enthusiasm as the seminar progressed. The potluck lunch was wonderful and offered everyone a chance to visit and share their thoughts. The building at Country Classics was very accommodating with lots of room and good lighting. The only question expressed by many at the conclusion of the seminar was, 'when is WSOTC bringing Connie back?'



### GENERAL INFORMATION

Entries will be limited to 6 TDX entries. The 1<sup>st</sup> 2 tracks will be designated in a special draw for those workers having certificates of prior WSOTC work per AKC & WSOTC procedures. Entries will be accepted until the official closing date, even though the advertised limit has been reached. If entry limits are exceeded, a drawing will be held on THURSDAY, November 8, 2018 at 4:00 PM, at the home of Marta Brock 9401 Blomberg St Olympia, WA 360-790-7037, to determine which entries will participate. The drawing shall be completely random. However, preference for entry in the TDX test will be given to those dogs that have not yet earned an AKC TDX title. When the advertised limit has been drawn, all remaining entries, subject to the same preferences set forth in the preceding paragraph, shall be assigned a position on an alternate list corresponding to the order in which they are drawn. Alternates, based on the Catalog order, who are present at the test site at the time of the Track drawing, will be used to replace absent dogs. Alternates not used will receive full refund of entry fees shortly after the test. WSOTC will also refund the entry fees to any confirmed entrant who does not participate in the test provided that the Test Secretary is notified prior to the Day of the Test and provided an alternate entry participates in the test as a result of the withdrawal.

**ACKNOWLEDGEMENTS** will be by phone, mailed or emailed by the Test Secretary after the closing of entries if the address is included in the entry. The Secretary will respond to email requests to confirm that entries are received. **Please** make sure all information is readable on your entry form! **AKC** Titles **ONLY!**.

### **TDX TEST**

All TDX entries must have passed an AKC TD or TDU test. Confirmed entries for the TDX test must be at the Test HQ by 10:00 AM, Sunday, December 2, 2018 at which time there will be a drawing for tracks for each dog entered. In the event of any absentees among the confirmed entries, the next alternate in catalog order who is present will be allowed to fill the vacancy.

Field cover: Prairie grasses, woods, gravel roads, may be water, wildlife, military operations/equipment and other personnel using areas.

**BITCHES IN SEASON** may participate subject to the provision set forth in Chapter 2, Section 8 of the AKC Tracking Regulations, effective February 1, 1998.

**REFRESHMENTS** will be provided on the morning of the test. A no-host lunch will be served for all exhibitors and spectators, and prizes awarded following completion of the TDX test at the TDX test site.

PRIZES: A plaque with the dog's track will be offered to all dogs passing this test.

DIRECTIONS TO SITE. As the actual area for the test on JBLM is not yet assigned, directions will be given after closing and on WSOTC's website. Most JBLM areas have spotty cell phone service. Cell phone day of test only. 360-708-4665.

I credit my successes with multiple dogs on my basic training philosophy:

- ATTITUDE IS EVERYTHING! The most important thing to me is building the "right" training relationship by building the the dog's "want to" attitude BEFORE adding the "have to". It is also important to me to keep the dog's positive attitude throughout their long show career by keeping training sessions fun.
- **ERROR-FREE TRAINING:** I create the finished dog by building on success, not failure, and the effective use of positive proofing to build confidence and consistency.
- REWARD-BASED TRAINING: I have control of the rewards and use them correctly to train, motivate to get the most out of my dog.
- FOCUS ON FUNDAMENTALS: I continue to focus on the foundational skills throughout the dog's show career.
