- Preference should be given to local recipients, but national groups may be considered
- The recipient should not be associated with radical animal rights organizations

Our two judges, Susan Leitner and Debby Wheeler came with challenging and fun courses. All went smoothly, with much thanks to R2 Agility ("the Robins") for helping us run the trial. Actually, they did a good deal of the work. For the last several years our contract with them has included many of the tasks previously carried out by the chair, something which makes taking on the agility chair a much more doable job. When Dee Carlson ran the trials, she had a lot more of the responsibilities, so this option is helpful for chairs who have a little less time to devote. They have been very easy to work with.

We had efficient course builders, a great ring crew, and great exhibitors, good sports, one and all who cheered on their fellow exhibitors. An added and popular attraction was the availability of *CGC* and Trick Dog titles, due to the efforts of Evaluator Paula Ratoza (also an agility judge, and who exhibited at our trials). Extra fun and titles for many who tried something new, and some income to support the trials. Thanks also to Argus Ranch who supplied the facility and other support for us. There has been some good news on the horizon for Argus, though not official, that it will remain in the hands of dog people.

The final financial report should be on our website now, but I can report that thanks to last minute entries which brought our total to pretty close to last year. That as well as the additional income from the Trick Dog and CGC evaluations brought our net income to over \$3,600. This includes a supply of ribbons/ rosettes that should last us at least for the next year or two.

Our catalog included a photo and biography for every judge; this allowed everyone learn a bit more about their judges. It was fun to hear the "I didn't know...." comments! Debbie Addicoat, Chris Primmer, Bruce Fraser and Chip Taylor were wonderful to work with and seemed to truly enjoy the trials and exhibitors.

- ATTITUDE IS EVERYTHING! The most important thing to me is building the "right" training relationship by building the the dog's "want to" attitude BEFORE adding the "have to". It is also important to me to keep the dog's positive attitude throughout their long show career by keeping training sessions fun.
- **ERROR-FREE TRAINING:** I create the finished dog by building on success, not failure, and the effective use of positive proofing to build confidence and consistency.
- REWARD-BASED TRAINING: I have control of the rewards and use them correctly to train, motivate to get the most out of my dog.
- FOCUS ON FUNDAMENTALS: I continue to focus on the foundational skills throughout the dog's show career.
