OTCH Point Schedule Changes

The AKC Board has approved proposals to modify the point schedule for earning the Obedience Trial Championship (OTCH), and they are in the February minutes that are now available on the web site.

A significant modification was amended by the board and staff after considering comments from the fancy. "One (1) Championship point will be recorded for those dogs that earn a qualifying score of 197 (increased from the original recommendation of 195) or better in the Open B or Utility B class, if they did not earn points based on the Point Schedule.








I am not sure if WSOTC members have been reading anything about a cardiac disease called Dilated Cardiomyopathy (DCM), which simply put is an enlargement of the heart, a very serious condition which can lead to death. Some breeds are particularly genetically prone, like Dobermans, but there is evidence that other breeds are getting this from the foods they eat, especially the grain free foods that are currently popular. It appears to be the presence of certain ingredients like peas and other legumes, potatoes, as well as the so called "boutique" foods that contain unusual protein sources such as kangaroo, rabbit and others. Here are a couple of links, though there is much more on line. There appears to be a concern particularly with Goldens, but many other breeds have been affected. EGRC will have a program on this.

These RAR only events are online/credit card registration only. If you are unable to register online, call our office at 253-854-9663 Monday to Thursday and Liz can take your credit card information over the phone.

Rent A Ring for Ring #1A -- 40 x 50 ring by the mirrors. Rent A Ring for Ring #1B – 40 x 50 ring closest to the parking lot.

Each ring Includes baby-gated ring, high, bar and broad jumps. Share with up to three other friends (at no additional charge) or train alone. No instruction provided. No judge provided. No rally equipment or signs provided; however, you may bring your own.

Rentals start on the hour and last for 55 minutes, starting at 9 am and ending at 4 pm. This will allow a transition time for folks to move equipment, etc. Cost: \$45 for 55 minutes, to be paid in full in advance by the person making the reservation. Your registration is not final until you are paid in full. You may sign up for multiple slots if they are available.
