

Cancelled Events & Application Fees

For all cancelled events in 2020, AKC will apply the event application fees to the club's next event of the same type, provided the club informs the AKC that the event has been cancelled. When applying for the next event, please provide the event number of the cancelled event on the new application form.

Late Event Application Fees

Clubs that wish to apply for an event, but may be past the deadline to apply, will have the late event application fee waived through the end of October 2020. This applies to all AKC sports.

Tracking Certifications

Any tracking certification that expires March 1, 2020 through December 31, 2020 will be granted an additional one-year extension, e.g., a certification that would expire October 1, 2020 will not expire until October 1, 2021.

- 2. **Approval of Minutes** Minutes from the March Board meeting were not available for approval.
- 3. **Report of the President** Thanks to Nancy for being the Zoom administrator. Thanks to Sharmin for all the help getting us on Zoom. Discussions will be held on using Zoom for the next General meeting as well as a date for the next General meeting. Note that some e-mails to and from Board members to Terrie have been bouncing back.
- 4. **Report of the Secretary** Notice from AKC giving updated e-mail addresses to contact AKC staff due to layoffs. AKC is working from home so e-mail is better than phone.

One person has requested a refund on their trophy donation. Sue says she is ready to write checks as soon as she hears from BaRay, don't have a time-line yet. Have requested a new contract from Jordan removing cancellation clause. If we have it at Fun-Fur- Paws will people come North for Trial and will we have a food vendor. If we do have Trial, premium list must state will hold indoors or outdoors depending on restrictions

- c. Membership New roster is not up to date. New members are not on the roster and have no information on getting on Members only page. The minutes from the Feb. 3 board meeting were approved as printed in the Canine Post.

Report of the President: Nancy Light's birthday was acknowledged. Amanda Buse, Don Rennick, Holly Krohn, Susan and JoAnne Mulligan and Jane Pitts were thanked for the work that went into planning the Spring trial. AKC was officially notified that WSOTC would not be holding a Fall Obedience/Rally trial Aug. 29/30. AKC had 6 trials on record.

Report of the Treasurer: Sue - The financial report for the month was reviewed

Committee reports:

Spring Trial Cancellation - Discussion was held and it was determined that participants would get a full refund of their entry fees. Terrie would send out a message on Facebook.

Fall Trial revisited - Discussion was held on finding a Fall date to hold a trial. It was determined that this was not feasible.

Agility - Nancy reported that Argus would continue to charge an increasing percentage of the rental fee if cancellation was delayed. Given the uncertainty of government mandates on social distancing it was determined a decision needs to be made before May 16 to prevent a large financial loss. The unreasonable contract with Argus was discussed. Nancy will continue to communicate with Argus on this.

Hearts and Flowers - It was reported that Gloria Newby made it safely home from the UK!

Diane Bauman Seminar - Discussion was held on moving the seminar to 2021 given the uncertainty of large group meetings in Oct. 2020. Diane is able to come June 12 and 13 of 2021. Nancy will check with Julie Germano to see if her building is available.
