PREZ'S MESSAGE

The year was 1946. Harry Truman was President. Donald Trump was born. Gas was 15¢ a gallon. Tupperware was introduced and the bikini made its debut in Paris. Troops were still coming home from the war.

The Cocker Spaniel was the most popular breed in America. AKC records show there were 26 obedience trials in the country that were not associated with all breed and specialty shows. The AKC recording fee was 25ϕ and the hot topic for the AKC delegates was benched vs un-benched shows. Benched shows exhausted dogs and handlers who were required to stay for the duration but allowed the public to see the breeds and talk to the breeders. Unbenched shows were easier on the dogs. If anyone left a benched show early they were fined \$5 by the AKC.

In Seattle, the year 1946 is remembered for the Valentines Day earthquake. However, in August during that busy year, a small group of dog lovers got together and formed an obedience club. They named it the Washington State Obedience Training Club. The sport of obedience was just over ten years old and rapidly growing.

"Obedience is not a passing fad but something to be taken seriously," were the words of Mrs. Helen Whitehouse Walker in 1934. At that time there was only one class. It consisted of heeling

on and off leash, a sit for two minutes, a down for 5 minutes with the owner out of sight, a drop on recall, retrieve of a 2 pound dumbbell regardless of the dog's size and a 42 inch jump to retrieve a slightly smaller dumbbell again regardless of the dog's size. The good news is that the dog only had to attempt the jump and was allowed to scale the jump to pass. The 42 inches came from the European Schutzhund standard of one meter. In 1936 AKC approved regulations and divided the obedience competition into classes, one class for professionals and one for amateurs. It was felt that competing against professionals or experienced trainers would be too discouraging for the novice trainer. The UD may have been added at this time or in the early 1940's and included 'speak on command' and a tracking title but no jumping.

There was a decline in competitive dog sports during the war years as dogs for defense became the focus. However, by 1946 an increased interest in obedience led the AKC to call an Obedience Advisory Committee. This committee helped to standardize judging procedures. They defined the principal part of the exercise and removed tracking from the UD, making it a separate title.

AKC required a club to have at least 25 members and WSOTC started with only 15 so the little WSOTC club had a ways to go before applying to AKC. That did not stop them from eagerly learning about dog training. During their first meeting they included a program viewing a 16 mm film featuring Blanche Saunders called Training You To Train Your Dog (1946). The film was produced by Gaines Dog Food. Blanche Saunders along with Helen Whitehouse Walker are considered the founders of AKC obedience. Ms. Saunders gave clinics around the country and wrote The Complete Book of Dog Obedience The Guide For Trainers.

In the words of WSOTC's longtime member, Betty Winthers, Blanche Saunders' film set the tone for WSOTC's mission. I researched the AKC Archives from 1946 to 1952 to obtain some of the above information. I also used information gleaned from articles written by Bob Self Sr in several 2002 copies of Front and Finish. There is much more to the history of our club and of AKC obedience. I am very much looking forward to our Club's Diamond Anniversary in 2021 and will continue our club's history as it intersects AKC obedience in future newsletters. - e. Program Sept General Meeting Sue had a suggestion for a program and Terrie will follow up on it.


