Did you know AKC now offers a Virtual Home Manners evaluation? Similar to the trick dog titles, you record your dog performing a series of ten behaviors, and then submit the video to a certified CGC evaluator. There is a version for both puppies and adults, which have different variations on the following exercises:

- Owner pets and grooms dog
- Sit on command
- Down on command
- Comes when called indoors (from 20 ft or another room)
- Manners related to food (owner has a snack, or own places food bowl)
- Doorbell/knock—dog behaves appropriately
- Go to place/crate, stay 1 minute
- Demonstrates relationship (choose from one of several games)
- Out for a walk (leash on, calmly exits door, and walks on a loose leash)
- Exercise outside (fetch or catch a toy, or other outdoor game)
