In consideration of the acceptance of this entry and of the holding of this event and to have the dog judged and to win prizes, ribbons or trophies, I (we) agree to hold the AKC, the event giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties and any AKC approved judge, judging at this event, harmless from any claim for loss or injuries which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto and I (we) personally assume all responsibility and liability for any such claim: and I (we) personally assume all responsibility and liability for any such claim: and I (we) further agree to hold the aforementioned parties harmless for any claim for loss or injury or damage to this dog.
