1. The meeting was called to order at 7:02. 2. **Report of the Board** - Terrie reported that our Spring trial chair has been injured and surgery to repair her knee will mean she won't be able to attend the trial. Sue Cox has agreed to step in as day chair. She said we will be needing extra support from club members to smooth over any unanticipated issues that might come up. Terrie asked members to please be ready to step up if asked to help. The WSOTC Spring trial closes March 13.

6. Committee Reports

Spring Trial 2024 - Amanda - We may need back up help for driving judges to and from their airports. We are in need of ring stewards. Also, clean up on Sunday will require designated volunteers. Double checking the grounds and stalls for garbage and dog poop is a must. There was discussion on ways to improve the poop scooping issue. Hand out poop bags at check-in; Jayne will set up an “adopt a poop” raffle. Jayne said this has been successful at other events.

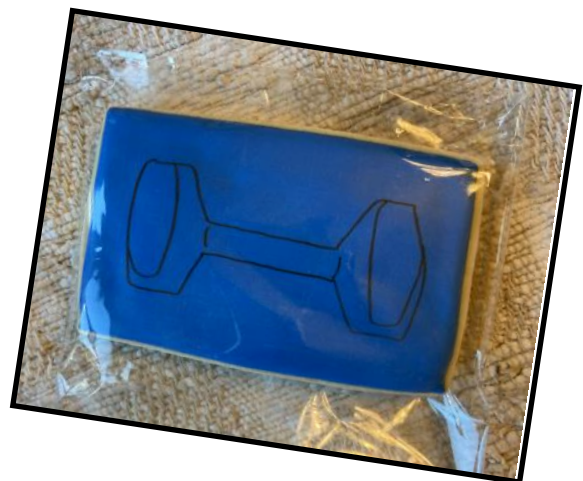

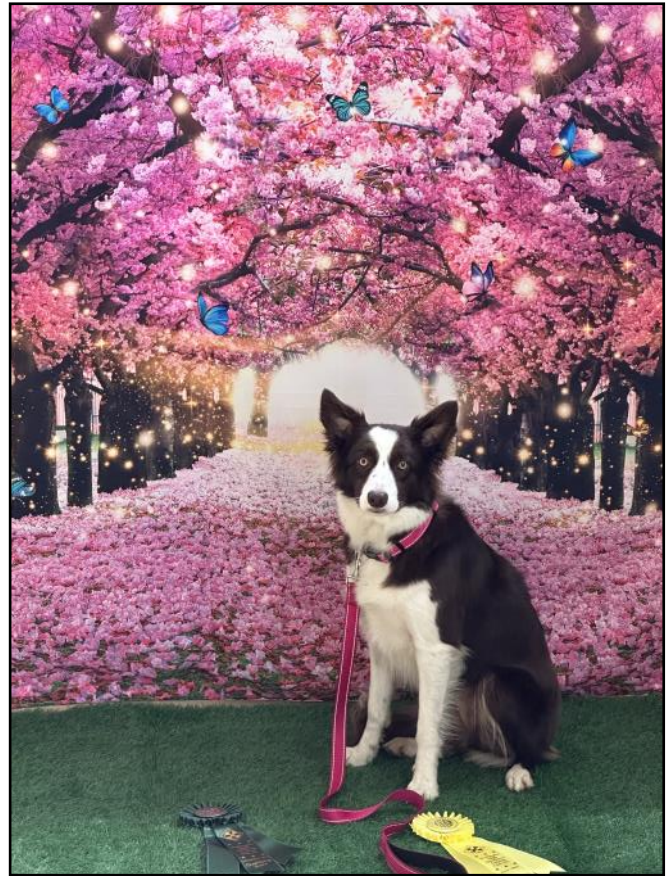


Nancy Light + Lia
