a. Discussion on archiving old information on the website.





Awards presentation followed. The Club's Personal Achievement Award was presented to Don Rennick.



I am not sure if WSOTC members have been reading anything about a cardiac disease called Dilated Cardiomyopathy (DCM), which simply put is an enlargement of the heart, a very serious condition which can lead to death. Some breeds are particularly genetically prone, like Dobermans, but there is evidence that other breeds are getting this from the foods they eat, especially the grain free foods that are currently popular. It appears to be the presence of certain ingredients like peas and other legumes, potatoes, as well as the so called "boutique" foods that contain unusual protein sources such as kangaroo, rabbit and others. Here are a couple of links, though there is much more on line. There appears to be a concern particularly with Goldens, but many other breeds have been affected. EGRC will have a program on this.
