#### RENT A RINGS ON TWO SATURDAYS: NOV. 9 AND 23, 2019

General Information: Rally will be offered in the mornings from 9 am to 10:45 am on Saturday, November 9 and 23. Obedience will be offered in the afternoons on those days, from 11 am to 3 pm. Each activity/day/ring has a separate sign-up page for each date. If you plan to sign up for multiple days/activities/time slots be sure to double-check your registration.

All registrations require payment at the time you register. There are limited time slots available, so register early. If you have questions or need assistance with registration, contact Liz in our office at 253-854-9663.

#### RALLY RENT A RING: NOV. 9 & 23, 2019 -- 9 AM TO 11 AM

Rally Rent A Ring – Masters Course – Ring #1 -- 40 x 50 ring by the mirrors. \$20 for 15 minutes. Share with up to three other friends (at no additional charge) or train alone. No instruction provided. No judge provided. Three time slots available: 9:00 am, 9:15 am and 9:30 am.

Rally Rent A Ring – Advanced/Excellent Course – Ring #1– 40 x 50 ring by the mirrors. \$20 for 15 minutes. Share with up to three other friends (at no additional charge) or train alone. No instruction provided. No judge provided. Three time slots available: 10:00 am, 10:15 am and 10:30 am. Rally Rent A Ring – Novice/Intermediate Course – Ring #2 -- 40 x 50 ring by the parking lot. \$20 for 15 minutes. Share with up to three other friends (at no additional charge) or train alone. No instruction provided. No judge provided. Six time slots available: 9:00 am, 9:15 am, 9:30 am, 9:45 am, 10:00 am, 10:15 am and, 10:30 am.

Rally ring rentals are limited to the times noted above. Both rings must end at 10:45 am to allow time for change-over to obedience.

#### OBEDIENCE RENT A RING: NOV. 9 & 23, 2019 - 11:00 AM TO 3:00 PM

Rent A Ring for Ring #1 -- 40 x 50 ring by the mirrors. Includes baby-gated ring, high, bar and broad jumps. Share with up to three other friends (at no additional charge) or train alone. No instruction provided. No judge provided. No rally equipment or signs provided; however, you may bring your own. Rent A Ring for Ring #2 -- 40 x 50 ring by the parking lot. Includes baby-gated ring, high, bar and broad jumps. Share with up to three other friends (at no additional charge) or train alone. No instruction provided. No judge provided. No rally equipment or signs provided; however, you may bring your own.

Rentals start on the hour and last for 55 minutes, starting at 11:00 am and ending at 3:00 pm. This will allow a transition time for folks to move equipment, etc. All of the ring times we are offering are listed below. Once you select the "Sign Up" option, only rental slots that remain available in that ring will show.

BE SURE TO MAKE A NOTE OF THE TIME(S) YOU SELECTED! The confirming email you get will only list the starting time of the Rent A Ring (the software does not show individual times in the confirming email). We will send everyone who registered a final email 24 hours prior to the event listing the names of everyone who registered, ring # and time.

No people or dog aggressive animals allowed. Dogs must be under control at all times. Soft crates may be set up ringside. Family Dog loaner crates may be available, but should not be moved.

Cost: \$45 for 55 minutes, to be paid in full in advance by person making the reservation. Your registration is not final until you are paid in full. You may sign up for multiple slots if they are available.

Register online by creating an account and paying by credit card. No refunds issued if you are unable to attend; however, you may sell your spot to someone provided you advise us via email to KathyL@FamilyDogOnline.com.

When you arrive, please check in with the staff member on duty and make sure everyone in your party signs the required hold harmless clause.
