**Report of the Secretary:** Rhonda – AKC sent approval for our trials on April 1st and 2nd, 2023.


**Report of the Treasurer:** Sue - the question of how much to transfer into savings needs to be addressed. The 2022-23 budget will be forwarded to the general membership.

The board has sent two budgets on to the membership for approval tonight. Remember that membership renewal is coming up.



### Announcing the New AKC FIT DOG Titles

The American Kennel Club is excited to announce the new AKC FIT DOG Titles. These titles are designed to provide a structured, individualized fitness plan that you and your dog can do together.

There are 3 levels of AKC fitness titles—Bronze, Silver, and Gold. Each title requires a specific number of activity points to be completed, which varies based on title level. Review the Participant Guide for more details.

Bronze—5 Points Silver—10 Points

Gold—20 Points

Within each title, there are 6 categories of activities to choose from to earn your points. AKC FIT DOG titles are noncompetitive, and dog owners may choose different activities to earn titles.

### **AKC Fitness Title Categories:**

- 1. AKC FIT DOG Course
- 2. Runs (community runs such as a Turkey Trot, Spring Scurry, etc.)
- 3. Walks and hikes (Independent or Group)
- 4. Unique to You and Your Dog (e.g., swimming, Parkour)
- 5. AKC Title that is fitness related (e.g., FAST CAT, agility)
- 6. AKC Parent Club Performance Titles (e.g., pack dog, sledding)

The AKC FIT DOG titles will officially launch in January of 2023 but we invite you to begin working towards these activities now to be one of the first to earn a title!

### Nancy Light + Lia

Lia was awarded her CCA, a title from the Golden Retriever Club of America. It stands for Conformation Certificate Assessment. Each Golden is measured and photographed, and then assessed by three evaluators against the AKC Golden breed standard. There are numerical scores for all the points of the standard and the dog must get at least 75% in average scores from each evaluator. It is non-competitive and intended for those of us not interested in competing in the show ring, geared more for working dogs, without all the grooming and glitz of the show ring. The Labradors have a similar event, and I am not aware of any other breeds that have this. It is intended to be educational, as the evaluators talk to you as they examine and score, and share what they see as faults and strong points in your dog. Temperaments are also evaluated in a "mingle" with three dogs interacting, to see if signs of aggression or timidity, which they also can evaluate in the individual examinations. Our breed standard requires "friendly, reliable, trustworthy".

#### WSOTC AWARD RULES AND APPLICATION -

Agility Obedience Rally Tracking Versatility

Plaques will be awarded annually at the February/March membership meeting to members who have received American Kennel Club (AKC) title(s) on their dog(s) *during the preceding calendar year*. The following rules apply:

- 1. Any or all titles must be received while a member of WSOTC.
- 2. Dogs must be owned or co-owned and handled by the WSOTC member.
- 3. For individual plaque awards, the member must have acquired 4 points by attending membership meetings, assisting at trials/events, service to the club, the year the titles were earned. No points are required for inclusion on the Perpetual plaques or for Top Dog award.
- 4. One plaque per dog will be awarded with the first title plate earned for the first AKC title earned in Agility, Obedience, Rally, or Tracking. Title plates only will be awarded in subsequent years for AKC titles.
- 5. Completed plague applications must be submitted to the Club Award Chairman by
- 6. Titles in **boldface** are those that are eligible for engraving on the perpetual honor plaques.

Plaques will be available at cost to those members not meeting requirements.
